2018 ENROLLMENT UPDATES

The 2018 Medicare Open Enrollment period runs between October 15 and December 7, 2017.

2018 HRA Credits

For 2018, FCA is pleased to contribute to your HRA as follows:

- Eligible retirees or surviving spouses will receive up to \$1,975.
- A spouse is eligible to receive up to \$1,750.

You can use your HRA credit to:

- Purchase health care coverage: Premiums for Medicare Part B, Part D, Advantage Plans, supplemental/Medigap plans, and voluntary coverage such as dental, vision or hearing.
- Pay for out-of-pocket health care expenses: Annual deductibles, coinsurance, copayments and health care expenses not reimbursed by any insurance.

Review the HRA Personal Report to confirm your credits and your personal information on file at Benefit Connect.

Medicare Open Enrollment Options

During the Medicare open enrollment period you can:

- Do nothing and keep your current Medicare medical and drug coverage as is.
- Switch to a Medicare Advantage plan from Original Medicare.
- Switch to Original Medicare from a Medicare Advantage plan.
- Change Medicare Advantage plans.
- Change Part D prescription drug plans, sign up for a drug plan if you don't have one now, or drop drug coverage.

Any changes you make will be effective January 1, 2018.

Review Your 2018 Medicare Coverage Options

It's a good idea to review your Medicare open enrollment options, even if you like your current plans. Life events and different health care needs may lead to considering a change in your coverage. Make sure you review the "Annual Notice of Change" sent from your current Medicare providers so you are aware of any changes coming in 2018 that may impact your personal situation. Here are some questions to ask as you explore other plans and coverage options:

- Does the prescription drug plan cover the medications you take? What are the coverage rules for drugs? Can you use your pharmacy or get mail-order prescriptions?
- Are your doctors and hospital in the health plan's network? Do you need to get referrals to see specialists?
- How much will you pay in premiums and out-of-pocket health care costs, such as deductibles, copayments and coinsurance?
- What is the plan's quality rating?
- Will you have coverage when you're out of state or the country?
- Do you have access to other coverage, such as group health through a current or former employer? How will Medicare work with that insurance?

Analyzing your health care needs for next year and looking at a variety of plans during open enrollment will help ensure you have the best coverage for 2018.
