NCRO Expansion Efforts

- Expand beyond Michigan-centric
 - Webinar in Toledo
 - Meetings in other areas
 - Toledo with Toledo and Perrysburg groups
 - Southwest Florida group
 - Possible meeting with California group
- Marketing effort
 - Outdoor billboards in Auburn Hills area

Pension Overpayment Update

- Things done so far...
 - Sent many communications to FCA
 - Discussed issue with outside sources and counsel
 - Met with Pension Rights Center – PRC
 - Sent communication to members seeking more who were affected and to provide next steps for them to take
 - Formed a committee to develop an action plan
 - Develop communication to Mike Keegan requesting a follow-up meeting
 - Developed an action plan if results of next meeting with FCA doesn't provide positive results
 - Met with FCA to discuss issue

Pension Overpayment Update

- Since our meeting with FCA...
 - FCA suspended collection from affected retirees
 - Sent follow-up communication to FCA
 - Requesting
 - update on their review
 - meeting to discuss final decision

NRLN Fly-In

- March 13-14th
- 10 NCRO attendees
- First day meeting
 - consisted of thorough review of advocacy issue
 - presentation on Medicare by Marilyn Moon, economist and policy analyst for American Institute for Research
- Despite bad weather and govt. shutdown managed to make 11 of 12 meetings

NRLN Fly-in

- Key advocacy issues...
 - If ACA is repealed/replaced, retain key features beneficial to seniors
 - Annual wellness exams
 - Close donut hole
 - Medicaid assistance for Long Term Care
 - Pre-existing conditions
 - Pass bills that will allow safe importation of drugs from Canada
 - Pass bills in Congress that will lower prescription drug prices
 - Request legislation to require pension plan sponsors to obtain approval from PBGC and IRS before combining pension plans
 - Met with Judiciary Committee to request changes in bankruptcy laws to better protect pensions and health care benefits

Big Concern

- Membership in retiree advocacy groups is getting smaller
- NCRO is not immune to that trend
- Retirees/seniors cannot lose their energy
